AMERICAN EAGLE GOLD CORP. (the "**Company**") is providing this information circular (the "**Information Circular**") and a form of proxy in connection with management's solicitation of proxies for use at the annual general and special meeting (the "**Meeting**") of the Company to be held on Thursday, October 19, 2023 at 12:00 p.m. (EST) and at any adjournments thereof. The Company will conduct its solicitation by mail and officers and employees of the Company may, without receiving special compensation, also telephone or make other personal contact. The Company will pay the cost of solicitation.

NOTICE-AND-ACCESS

The Company has elected to use the notice and access provisions ("**Notice and Access Provisions**") for the Meeting pursuant to National Instrument 54-101 - *Communication with Beneficial Owners of Securities of a Reporting Issuer* ("**NI 54-101**") with respect to the mailing to its non-registered (beneficial) shareholders. The Notice and Access Provisions allow the Company to post proxy-related materials both on SEDAR and a non-SEDAR website, rather than delivering the materials by mail. Shareholders will receive a Notice of Meeting and a form of proxy or voting instruction form and may choose to receive a printed paper copy of the Information Circular.

The Company is not using procedures known as 'stratification' in relation to the Notice and Access Provisions. Stratification occurs when a reporting issuer using the Notice and Access Provisions provides a paper copy of the Information Circular to some, but not all, Shareholders with the Notice of Meeting.

APPOINTMENT OF PROXYHOLDER

The purpose of a proxy is to designate persons who will vote the proxy on a shareholder's behalf in accordance with the instructions given by the shareholder in the proxy. The persons whose names are printed in the enclosed form of proxy are officers or directors of the Company (the "**Management Proxyholders**").

A shareholder has the right to appoint a person other than a Management Proxyholder, to represent the shareholder at the Meeting by striking out the names of the Management Proxyholders and by inserting the desired person's name in the blank space provided or by executing a proxy in a form similar to the enclosed form. A proxyholder need not be a shareholder.

VOTING BY PROXY

If a shareholder does not specify a choice and the shareholder has appointed one of the Management Proxyholders as proxyholder, the Management Proxyholder will vote in favour of the matters specified in the Notice of Meeting and in favour of all other matters proposed by management at the Meeting.

NON-REGISTERED HOLDERS

Only Shareholders whose names appear on the records of the Company as the registered holders of shares or duly appointed proxyholders are permitted to vote at the Meeting. Most Shareholders of the Company are "non-registered" shareholders because the shares they own are not registered in their names but instead registered in the name of a nominee such as a brokerage firm through which they purchased the shares; bank, trust company, trustee or administrator of self-administered RRSP's, RRIF's, RESP's and similar plans; or clearing agency such as The Canadian Depository for Securities Limited (a "Nominee"). If you purchased your shares through a broker, you are likely a non-registered holder.

In accordance with securities regulatory policy, the Company has distributed copies of the Meeting Materials, being the notice of meeting, this Information Circular and the proxy, to the Nominees for distribution to non-registered holders.

Nominees are required to forward the Meeting Materials to non-registered holders to seek their voting instructions in advance of the Meeting. Shares held by Nominees can only be voted in accordance with the instructions of the non-registered holder. The Nominees often have their own form of proxy, mailing procedures and provide their own return instructions. If you wish to vote by proxy, you should carefully follow the instructions from the Nominee in order that your shares are voted at the Meeting.

If you, as a non-registered holder, wish to vote at the Meeting in person, you should appoint yourself as

proxyholder by writing your name in the space provided on the request for voting instructions or proxy provided by the Nominee and return the form to the Nominee in the envelope provided. Do not complete the voting section of the form as your vote will be taken at the Meeting.

Nomination of Directors

The Board has responsibility for identifying potential Board candidates. The Board assesses potential Board candidates to fill perceived needs on the Board for required skills, expertise, independence and other

factors. Members of the Board and representatives of the resource exploration industry are consulted for possible candidates.

Compensation of Directors and the CEO

As at the Record Date, the Company's independent Director is Kurt Breede. The independent director has the responsibility for determining compensation for the Directors and senior management.

To determine compensation payable, the independent Director reviews compensation paid for Directors and CEOs of companies of similar size and stage of development in mineral exploration and determine an appropriate compensation reflecting the need to provide incentive and compensation for the time and effort expended by the Directors and senior management while taking into account the financial and other resources of the Company. In setting the compensation, the independent Director annually reviews the performance of the CEO and senior management in light of the Company's objectives.

Other Board Committees

As the directors are actively involved in the operations of the Company and the size of the Company's operations does not warrant a larger Board, the Board has determined that additional committees are not necessary at this stage of the Company's development.

Assessments

The Board does not consider that formal assessments would be useful at this stage of the Company's development. The Board conducts informal annual assessments of the Board's effectiveness, the individual directors and each of its committees. To assist in its review, the Board conducts informal surveys of its directors.

PARTICULARS OF MATTERS TO BE ACTED UPON

To the knowledge of the Board, the matters to be brought before the Meeting are those matters set forth in the accompanying Notice of Meeting, including the proposed change of business as summarized below:

1. REPORT AND FINANCIAL STATEMENTS

The Board of the Company has approved all of the information in the audited financial statements of the Company for the years ended December 31, 2022 and 2021 and the report of the auditor thereon, copies of which are delivered herewith.

2. FIX NUMBER OF DIRECTORS TO BE ELECTED AT THE MEETING

Shareholders of the Company will be asked to consider and, if thought appropriate, to approve and adopt an ordinary resolution fixing the number of directors to be elected at the Meeting. In order to be effective, an ordinary resolution requires the approval of a majority of the votes cast by shareholders who vote in respect of the resolution.

At the Meeting, it will be proposed that five (5) directors be elected to hold office until the next annual general meeting or until their successors are elected or appointed. **Unless otherwise directed, it is the intention of the Management Proxyholders, if named as proxy, to vote in favour of the ordinary resolution fixing the number of directors to be elected at the Meeting at five (5).**

3. ELECTION OF DIRECTORS

The Company currently has four (4) directors and all of these directors are being nominated for re-election at the Meeting, along with one (1) additional director. The following table sets forth the name of each of the persons proposed to be nominated for election as a director, all positions and offices in the Company presently held by such nominee, the nominee's municipality of residence, principal occupation at the present and during the preceding five years, the period during which the nominee has served as a director, and the number and percentage of Common Shares of the Company that the nominee has advised are beneficially owned by the nominee, directly or indirectly, or over which control or direction is exercised, as of the date of this Information Circular.

Unless otherwise directed, it is the intention of the Management Proxyholders, if named as proxy, to vote for the election of the persons named in the following table to the Board of Directors. Each director elected will hold office until the next annual general meeting of shareholders or until his successor is duly elected, unless his office is earlier vacated in accordance with the by-laws of the Company or the provisions of the OBCA to which the Company is subject.

4. APPOINTMENT OF AUDITORS

The Shareholders will be asked to vote for the reappointment of McGovern Hurley LLP, Chartered Accountants, of Toronto, Ontario, to hold office until the next annual general meeting of Shareholders. McGovern Hurley LLP have been the auditors for the Company since November 2021. **Unless otherwise directed, it is the intention of the Management Proxyholders, if named as proxy, to vote in favour of the appointment of McGovern Hurley LLP to hold office for the ensuring year.**

5. APPROVAL OF STOCK OPTION PLAN

The Company's Stock Option Plan is a 20% fixed option plan that was previously approved by disinterested Shareholders on August 8, 2022 (the "**Stock Option Plan**"). Pursuant to Policy 4.4 of the Exchange, Shareholder approval is required to amend the amount of securities issuable under a fixed stock option plan. At the Meeting, Shareholders will be asked to consider an ordinary resolution of disinterested Shareholders approving amendments to the Stock Option Plan (the "**Option Plan Resolution**").

The Stock Option Plan is a 20% fixed option plan which reserves a fixed number of Common Shares for issuance pursuant to its terms. As at the date of this Information Circular a total of 13,949,358 Common Shares are reserved for issuance and eligible to be issued pursuant to the Stock Option Plan. A total of 14,300,000 Common Shares are currently reserved for issuance (including the 500,000 options approved for issuance by the Board on August 2, 2023, upon shareholder approval of which is sought at the Meeting, as more fully described below) pursuant to stock options previously issued under the Stock Option Plan, 9,550,000 of which are held by Insiders.

As at the date of this Information Circular, the Company has a total of 96,265,238 Common Shares outstanding. The Company will seek disinterested Shareholder approval to increase the number of Common Shares available under the Stock Option Plan as amended to match the current 20% calculation of the Common Shares outstanding. Therefore, the Company seeks to amend the Stock Option Plan to increase the issuable Common Shares under the Stock Option Plan to 19,253,047 Common Shares.

In accordance with the policies of the Exchange, the approval of the Option Plan Resolution will require disinterested Shareholder approval, being the approval of a majority of the votes cast by Shareholders at the Meeting excluding Insiders and any Associates and Affiliates thereof. As of the date of this Information Circular, Insiders and Associates and Affiliates thereof that are prohibited from voting on the Option Plan Resolution hold an aggregate of 15,767,355 Common Shares, representing 16% of the issued and outstanding Common Shares of the Company, which shares will be excluded for the purposes of determining whether the amendments to the Stock Option Plan are approved. The proposed amendments to the Stock Option Plan are also subject to approval by the Exchange.

Further, the Company has made clarifying revisions to section 3.2 of the Stock Option Plan regarding the limits on the shares that are issuable pursuant to the Stock Option Plan. Such clarifications include that:

- the percentage of shares reserved under the Stock Option Plan shall not exceed 19,253,047;
- the maximum number of shares that may be issued to Insiders (as a group) must not exceed 10% of the issued and outstanding at any point in time (unless the Company has obtained disinterested Shareholder approval); and
- Eligible Charitable Organizations (as such term is defined in Exchange Policy 4.4) shall not be eligible to receive any Security Based Compensation (as such term is defined in Exchange Policy 4.4) other than Options if the Common Shares are listed on the Exchange at the time of any issuance or grant.

A copy of the proposed updated Stock Option Plan is attached hereto as Schedule "B".

Unless otherwise directed, it is the intention of the Management Proxyholders to vote proxies in favour of the Option Plan Resolution. In order to be effective, the Option Plan Resolution requires approval of a majority of the votes cast by the disinterested Shareholders who vote in respect to the Option Plan Resolution.

The text of the ordinary resolution to be considered at the Meeting will be substantially as follows:

"Be it resolved as an ordinary resolution of the disinterested Shareholders of the Company that:

- 1. the stock option plan of the Company be approved substantially in the form attached hereto as Schedule "B" (the "Stock Option Plan") and the Stock Option Plan be and is hereby ratified, approved and adopted as the stock option plan of the Company;
- 2. the form of the Stock Option Plan may be amended in order to satisfy the requirements or requests of any regulatory authorities without requiring further approval of the shareholders of the Company;
- 3. the issued and outstanding stock options previously granted shall be continued under and governed by the Stock Option Plan;

- 4. the shareholders of the Company hereby expressly authorize the board of directors to revoke this resolution before it is acted upon without requiring further approval of the shareholders in that regard; and
- 5. any one (or more) director or officer of the Company is authorized and directed, on behalf of the Company, to take all necessary steps and proceedings and to execute, deliver and file any and all declarations, agreements, documents and other instruments and do all such other acts and things (whether under corporate seal of the Company or otherwise) that may be necessary or desirable to give effect to this ordinary resolution."

5. <u>APPROVAL OF ESROW OPTIONS</u>

On August 2, 2023, the Directors of the Company approved the grant of a total of 500,000 stock options to certain eligible participants incentive stock options (the "**Escrowed Options**") pursuant to the Stock Option Plan. The Escrowed Options have been reserved for issuance, but as at the date of this Circular, have not vested and the Common Shares underlying the Escrowed Options have not become issuable, and shall remain in escrow pending disinterested shareholder approval of the Escrowed Option Resolution (as defined below).

At the Meeting, disinterested Shareholders will be asked to consider, and if thought fit, approve an ordinary resolution of disinterested Shareholders ratifying the grant of the Escrowed Options (the "**Escrowed Option Resolution**").

The Escrowed Options were approved by the Board, and includes the issuance of 400,000 Escrowed Options to directors and officers of the Company. All of the Escrowed Options are exercisable into a Common Share at a price of \$0.30 per Escrowed Option. The Escrowed Options were issued at a price above the market price of the Common Shares on the date of grant, which was \$0.26 on August 1, 2023. The Escrowed Options vest one year from the date of grant on August 2, 2024, and expire on August 2, 2028.

As the Stock Option Plan (prior to successful amendment of same at the Meeting) currently reserves only 13,949,358 Common Shares, and 13,800,000 options were previously issued, the issuance of the Escrowed Options requires disinterested Shareholder approval pursuant to TSXV Policy 4.4, being the approval of a majority of the votes cast by Shareholders at the Meeting excluding the holders of the Escrowed Options and any Associates and Affiliates thereof. As such, the Escrowed Option Resolution will exclude 11,625,000 Common Shares (representing 12% of the issued and outstanding Common Shares) which are held by Shareholders who also have an interest in the Escrowed Options.

Unless otherwise directed, it is the intention of the Management Proxyholders to vote proxies in favour of the Escrowed Option Resolution. In order to be effective, the Escrowed Option Resolution requires approval of a majority of the votes cast by the disinterested Shareholders who vote in respect to the Escrowed Option Resolution.

The text of the ordinary resolution to be considered at the Meeting will be substantially as follows:

"Be it resolved as an ordinary resolution of the disinterested Shareholders of the Company that:

1. the grant of a total of 500,000 stock options, exercisable into common shares in the capital of the Company to the individuals in the amounts and with the characteristics as detailed below (the "Options"), be and is hereby ratified and approved;

- 2. 500,000 common shares in the capital of the Company, being the common shares underlying the Options, be and are hereby allotted to each optionee, and, subject to the right of an optionee to exercise an Option in whole or in part, upon receipt from each optionee of the form and amount of consideration payable upon exercise, the common shares for which an option is duly exercised be issued as fully paid and non-assessable shares in the capital of the Company, and the stated capital account of the Company for the Shares concerned be adjusted accordingly;
- 3. any director or officer of the Company be and hereby is authorized to execute and deliver option agreements with the terms set out above on behalf of the Company, such option agreements to be in such form as such director or officer may determine;
- 4. any two officers or directors of the Company be and are hereby authorized to issue treasury orders and to take all necessary action to cause the issuance of common shares upon the exercise of the options granted herein;
- 5. any acts taken prior to the effective date of this resolution by any director or officer of the Company in connection with this resolution is hereby approved, ratified and confirmed;
- 6. the shareholders of the Company hereby expressly authorize the board of directors to revoke this resolution before it is acted upon without requiring further approval of the shareholders in that regard; and
- 7. any one (or more) director or officer of the Company is authorized and directed, on behalf of the Company, to take all necessary steps and proceedings and to execute, deliver and file any and all declarations, agreements, documents and other instruments and do all such other acts and things (whether under corporate seal of the Company or otherwise) that may be necessary or desirable to give effect to this ordinary resolution."

6. APPROVAL TO RE-ACQUIRE 20% INTEREST IN NAK PROJECT

On October 11, 2022, the Company and Orecap Invest Corp (formerly Orefinders Resources Inc.) ("**Orecap**") entered into an option agreement (the "**Option Agreement**") and a call option agreement (the "**Call Option Agreement**"). The Option Agreement granted Orecap the option to earn a 20% interest (the "**Interest**") in the Company's NAK Copper-Gold Porphyry project, consisting of 5 mineral claims located northeast of Smithers, British Columbia (the "**Project**"). Pursuant to the Option Agreement, Orecap was

entitled to receive the Interest in return for the completion by Orecap of an aggregate of \$1 million in exploration work obligations on the Project by the end of 2022.

In December 2022, in accordance with the Option Agreement and following the completion of the 2022 drill program, Orecap acquired the Interest in the Project from the 100% interest that the Company is earning under its option agreement which was entered into on December 10, 2021 (the "**Original Option Agreement**") where the Company assumed all of the rights and interest of the vendor on the Project under the terms of an option agreement between the vendor and the underlying claim owner. The outstanding obligations of the Company under the Original Option Agreement to earn 100% interest in the NAK Project (which Orecap has currently earned 20% of) include a payment of either \$75,000 or 1,000,000 Common Shares on or before April 30, 2024 and a payment of either \$150,000 or 1,000,000 Common Shares 30 days following the public disclosure of an inferred or greater resource with a minimum of 1,000,000 ounces of gold or gold equivalent. If the option holder elects to receive the payments in Common Shares, the maximum value of the Common Shares for each of the payments will not exceed \$150,000 and \$225,000, respectively, based on 10-day volume weighted average price on the day that the payment becomes due.

The Call Option Agreement provides the Company the ability to repurchase the Interest from Orecap at a price of \$1.5 million (the "**Repurchase Price**"), which is subject to regulatory approvals, including the approval of the TSXV. The Repurchase Price for the reacquisition of the Interest may be paid in cash or by the issuance of Common Shares of the Company, at the sole option of the Company. If the payment for the repurchase of the Interest is made in Common Shares of the Company, the quantum of shares shall be determined by dividing the Repurchase Price into the price per share of the Common Shares as equal to the volume weighted trading price of the Company's shares on the TSXV for the fifteen trading days ending three business days prior to the closing date.

At the Meeting, disinterested Shareholders will be asked to consider, and if thought fit, approve an ordinary resolution of disinterested Shareholders approving the repurchase of the Interest by the Company in accordance with the Call Option Agreement by the payment of the Repurchase Price in cash or in the issuance of Common Shares of the Company (the "NAK Call Option Resolution").

The Company and Orecap have certain directors and officers in common, and as such, the Option Agreement and Call Option Agreement are non-arm's length transactions according to the policies of the TSXV.

When the Company entered into the Option Agreement and the Call Option Agreement in order fund the expansion of the 2022 drill program on the Project, the Company's shares price was \$0.02. As a result of the ongoing exploration activity and other corporate developments to date, the share price of the Company has increased to approximately \$0.29, evidencing the value of Option Agreement to the Company and therefore the value of the Interest.

The Company intends to exercise its option to re-acquire the Interest from Orecap prior to its expiry on April 30, 2024 and requires shareholder approval in order to meet regulatory requirements and receive the approval of the TSXV.

The number of Common Shares required to be issued to satisfy the Repurchase Price is determined based on the trading activity of the Company's Common Shares on the TSXV. If the payment for repurchase of the Interest were to be made in Common Shares of the Company based on the volume weighted trading price of the Company's shares on the TSXV for the fifteen trading days ended on the Record Date, the Company would need to issue a total of 5,689,313 Common Shares to Orecap to satisfy the Repurchase Price. In addition to the 4,861,004 Common Shares currently held by Orecap, Orecap would hold a total of 10,550,317 Common Shares, representing 10.3% of the issued and outstanding Common Shares as at the Record Date. This number of shares is approximately 9% of the Common Shares that would have been issuable for the Repurchase Price using the equivalent calculation as at October 11, 2022, the date the Option Agreement was entered into, which would result in the need to issue 63,202,677 Common Shares.

In order to limit the number of Common Shares that may be issued while providing sufficient flexibility for the Company to reacquire the interest using Common Shares (a calculation that is dependent on inputs outside of the Company's control), 15,000,000 shares, equal to a volume weighted trading price of the Company's shares on the TSXV of \$0.10, is proposed as an upper limit on the number of shares that may be issued in association with the Repurchase Price. If the required number of Common Shares to satisfy the Repurchase Price is greater than 15,000,000, the balance of the Repurchase Price would be required to be paid in cash. If this limit was reached, it would result in Orecap holding a total of 19,861,004 Common Shares, representing 17.9% of the proforma issued and outstanding Common Shares as at the Record Date.

In accordance with TSXV Policy 5.3, the vote for this resolution will exclude 25,934,343 Common Shares (representing 27% of the issued and outstanding Common Shares) which are held directly by Orecap and are beneficially held by Shareholders who are Insiders of Orecap.

Unless otherwise directed, it is the intention of the Management Proxyholders to vote proxies in favour of the NAK Call Option Resolution. In order to be effective, the NAK Call Option Resolution requires approval of a majority of the votes cast by the disinterested Shareholders who vote in respect to the NAK Call Option Resolution.

The text of the ordinary resolution to be considered at the Meeting will be substantially as follows:

"Be it resolved as an ordinary resolution of the disinterested Shareholders of the Company that:

- 1. the re-purchase of the 20% interest in the NAK project from Orecap Invest Corp. on or before April 30, 2024, pursuant to a call option agreement dated October 11, 2022 between the Company and Orecap Invest Corp. (the "Transaction") along with all matters related thereto and transactions contemplated therein be and is hereby ratified and approved;
- 2. payment of the purchase price for the Transaction in the amount of \$1,500,000 (the "Re-purchase Price"), in cash or in the issuance of common shares in the capital of the Company ("Common Shares") at the sole option of board of directors of the Company, be and is hereby approved, and the board of directors are hereby authorized to determine the method of payment thereof;
- 3. in the event that the board of directors elects to pay the Re-purchase Price set out above by the issuance of Common Shares, such applicable number of Common Shares, in any case not to exceed 15,000,000, be and are hereby approved for reservation and allotment to be issued in connection with the Transaction;
- 4. any acts taken prior to the effective date of this resolution by any director or officer of the Company in connection with this resolution is hereby approved, ratified and confirmed;
- 5. the shareholders of the Company hereby expressly authorize the board of directors to revoke this resolution before it is acted upon without requiring further approval of the shareholders in that regard; and
- 6. any one (or more) director or officer of the Company is authorized and directed, on behalf of the Company, to take all necessary steps and proceedings and to execute, deliver and file any and all declarations, agreements, documents and other instruments and do all such other acts and things (whether under corporate seal of

the Company or otherwise) that may be necessary or desirable to give effect to this ordinary resolution."

SCHEDULE "A"

AUDIT COMMITTEE CHARTER

The Audit Committee's Charter

I. Mandate

The primary function of the audit committee (the **"Committee"**) is to assist the Board of Directors in fulfilling its financial oversight responsibilities by reviewing the financial reports and other financial information provided by American Eagle Gold Corp. (the **"Company"**) to regulatory authorities and shareholders, the Company's systems of internal controls regarding finance and accounting, and the Company's auditing, accounting and financial reporting processes. Consistent with this function, the Committee will encourage continuous improvement of, and should foster adherence to, the Company's policies, procedures and practices at all levels. The Committee's primary duties and responsibilities are to:

- Serve as an independent and objective party to monitor the Company's financial reporting and internal control system and review the Company's financial statements.
- Review and appraise the performance of the Company's external auditors.
- Provide an open avenue of communication among the Company's auditors, financial and senior management and the Board of Directors.

II. Composition

The Committee shall be comprised of three directors as determined by the Board of Directors, the majority of whom shall be free from any relationship that, in the opinion of the Board of Directors, would interfere with the exercise of his or her independent judgment as a member of the Committee.

At least one member of the Committee shall have accounting or related financial management expertise. All members of the Committee that are not financially literate will work towards becoming financially literate to obtain a working familiarity with basic finance and accounting practices. For the purposes of the Company's Charter, the definition of "financially literate" is the ability to read and understand a set of financial statements that present a breadth and level of complexity of accounting issues that are generally comparable to the breadth and complexity of the issues that can presumably be expected to be raised by the Company's financial statements.

The members of the Committee shall be elected by the Board of Directors at its first meeting following the annual shareholders' meeting. Unless a Chair is elected by the full Board of Directors, the members of the Committee may designate a Chair by a majority vote of the full Committee membership.

III. Meetings

The Committee shall meet a least twice annually, or more frequently as circumstances dictate. As part of its job to foster open communication, the Committee will meet at least annually with the Chief Financial Officer and the external auditors in separate sessions.

IV. Responsibilities and Duties

To fulfill its responsibilities and duties, the Committee shall:

Documents/Reports Review

- 1. Review and update this Charter annually.
- 2. Review the Company's financial statements, MD&A and any annual and interim earnings, press releases before the Company publicly discloses this information and any reports or other financial information (including quarterly financial statements), which are submitted to any governmental body, or to the public, including any certification, report, opinion, or review rendered by the external auditors.

External Auditors

- 3. Review annually the performance of the external auditors who shall be ultimately accountable to the Board of Directors and the Committee as representatives of the shareholders of the Company.
- 4. Obtain annually, a formal written statement of external auditors setting forth all relationships between the external auditors and the Company, consistent with Independence Standards Board Standard 1.
- 5. Review and discuss with the external auditors any disclosed relationships or services that may impact the objectivity and independence of the external auditors.
- 6. Take, or recommend that the full Board of Directors take, appropriate action to oversee the independence of the external auditors.
- 7. Recommend to the Board of Directors the selection and, where applicable, the replacement of the external auditors nominated annually for shareholder approval.
- 8. At each meeting, consult with the external auditors, without the presence of management, about the quality of the Company's accounting principles, internal controls and the completeness and accuracy of the Company's financial statements.
- 9. Review and approve the Company's hiring policies regarding partners, employees and former partners and employees of the present and former external auditors of the Company.
- 10. Review with management and the external auditors the audit plan for the year-end financial statements and intended template for such statements.
- 11. Review and pre-approve all audit and audit-related services and the fees and other compensation related thereto, and any non-audit services, provided by the Company's external auditors. The pre-approval requirement is waived with respect to the provision of non-audit services if:
 - i. the aggregate amount of all such non-audit services provided to the Company constitutes not more than five percent of the total amount of revenues paid by the Company to its external auditors during the fiscal year in which the non-audit services are provided;
 - ii. such services were not recognized by the Company at the time of the engagement to be non-audit services; and
 - iii. such services are promptly brought to the attention of the Committee by the Company and approved prior to the completion of the audit by the Committee or by one or more members of the Committee who are members of the Board of Directors to whom authority to grant such approvals has been delegated by the Committee.

Provided the pre-approval of the non-audit services is presented to the Committee's first scheduled meeting following such approval such authority may be delegated by the Committee to one or more independent members of the Committee.

Financial Reporting Processes

- 12. In consultation with the external auditors, review with management the integrity of the Company's financial reporting process, both internal and external.
- 13. Consider the external auditors' judgments about the quality and appropriateness of the Company's accounting principles as applied in its financial reporting.
- 14. Consider and approve, if appropriate, changes to the Company's auditing and accounting principles and practices as suggested by the external auditors and management.
- 15. Review significant judgments made by management in the preparation of the financial statements and the view of the external auditors as to appropriateness of such judgments.
- 16. Following completion of the annual audit, review separately with management and the external auditors any significant difficulties encountered during the course of the audit, including any restrictions on the scope of work or access to required information.
- 17. Review any significant disagreement among management and the external auditors in connection with the preparation of the financial statements.
- 18. Review with the external auditors and management the extent to which changes and improvements in financial or accounting practices have been implemented.
- 19. Review any complaints or concerns about any questionable accounting, internal accounting controls or auditing matters.
- 20. Review certification process.
- 21. Establish a procedure for the confidential, anonymous submission by employees of the Company of concerns regarding questionable accounting or auditing matters.

Risk Management

- 22. To review, at least annually, and more frequently if necessary, the Company's policies for risk assessment and risk management (the identification, monitoring, and mitigation of risks).
- 23. To inquire of management and the independent auditor about significant business, political, financial and control risks or exposure to such risk.
- 24. To request the external auditor's opinion of management's assessment of significant risks facing the Company and how effectively they are being managed or controlled.
- 25. To assess the effectiveness of the over-all process for identifying principal business risks and report thereon to the Board.

<u>Other</u>

26. Review any related-party transactions.

SCHEDULE "B"

STOCK OPTION PLAN

1. PURPOSE

The purpose of this stock option plan (the "**Plan**") of **American Eagle Gold Corp.** (the "**Company**"), a corporation incorporated under the *Business Corporation Act* (Ontario), is to advance the interests of the Company by encouraging the directors, officers, employees and consultants of the Company, and of its subsidiaries and affiliates, if any, to acquire common shares in the share capital of the Company (the "**Shares**"), thereby increasing their proprietary interest in the Company, encouraging them to remain associated with the Company and furnishing them with additional incentive in their efforts on behalf of the Company in the conduct of its affairs.

2. IMPLEMENTATION AND ANNUAL APPROVAL

The Plan shall be approved by the Board of Directors and shareholders of the Company at the time it is implemented.

3. ADMINISTRATION

- 3.1 The Plan shall be administered by the Board of Directors of the Company or by a special committee of the directors appointed from time to time by the Board of Directors of the Company pursuant to rules of procedure fixed by the Board of Directors (such committee or, if no such committee is appointed, the Board of Directors of the Company, is hereinafter referred to as the "**Board**"). A majority of the Board shall constitute a quorum, and the acts of a majority of the directors present at any meeting at which a quorum is present, or acts unanimously approved in writing, shall be the acts of the Board.
- 3.2 Subject to the provisions of the Plan, the Board shall have authority to construe and interpret the Plan and all option agreements entered into hereunder, to define the terms used in the Plan and in all option agreements entered into hereunder, to prescribe, amend and rescind rules and regulations relating to the Plan and to make all other determinations necessary or advisable for the administration of the Plan. All determinations and interpretations made by the Board shall be binding and conclusive on all participants in the Plan and on their legal personal representatives and beneficiaries.
- 3.3 Each option ("**Option**") to purchase a Share granted hereunder may be evidenced by an agreement in writing, signed on behalf of the Company and by the optionee, in such form as the Board shall approve. Each such agreement shall recite that it is subject to the provisions of this Plan.
- 3.4 Each Option granted by the Company prior to the date of the approval of the Plan by the shareholders of the Company, including Options granted under previously approved stock option plans of the Company, be and are continued under and shall be subject to the terms of the Plan after the Plan has been approved by the shareholders of the Company.

4. STOCK EXCHANGE RULES

All Options granted pursuant to this Plan shall be subject to rules and policies of any stock exchange or exchanges on which the Shares of the Company are then listed and any other regulatory body having jurisdiction hereinafter (hereinafter collectively referred to as, the "**Exchange**").

5. SHARES SUBJECT TO PLAN

- 5.1 Subject to adjustment as provided in Section 19 hereof, the Shares to be offered under the Plan shall consist of Shares of the Company's authorized but unissued Shares. The aggregate number of Shares issuable upon the exercise of all Options granted under the Plan shall be fixed at 19,183,048 Shares. If any Option granted hereunder is settled in cash, cancelled, terminated, expired, surrendered, or forfeited for any reason in accordance with the terms of the Plan without being exercised, the unpurchased Shares subject thereto shall again be available for the purpose of this Plan.
- 5.2 **"Security Based Compensation**" has the meaning ascribed to "security based compensation" in Policy 4.4 *Security Based Compensation* of the TSX Venture Exchange, as amended from time to time.
- 5.3 **"Share Compensation Arrangement**" has the meaning ascribed to "security based compensation arrangements" in Part VI of the Company Manual of the Toronto Stock Exchange (the **"TSX**"), as amended from time to time.

6. MAINTENANCE OF SUFFICIENT CAPITAL

The Company shall at all times during the term of the Plan reserve and keep available such numbers of Shares as will be sufficient to satisfy the requirements of the Plan.

7. ELIGIBILITY AND PARTICIPATION

- 7.1 Directors, officers, consultants, and employees of the Company or its subsidiaries, and employees of a person or company which provides management services to the Company or its subsidiaries ("**Management Company Employees**") shall be eligible for selection to participate in the Plan (such persons hereinafter collectively referred to as "**Participants**"). Subject to compliance with applicable requirements of the Exchange, Participants may elect to hold Options granted to them in an incorporated entity wholly owned by them and such entity shall be bound by the Plan in the same manner as if the Options were held by the Participant.
- 7.2 Subject to the terms hereof, the Board shall determine to whom Options shall be granted, the terms and provisions of the respective Option agreements, the time or times at which such Options shall be granted and vested, and the number of Shares to be subject to each Option. No Option may be granted or issued unless the Option is allocated to a particular Participant. In the case of employees or consultants of the Company or Management Company Employees, the Option agreements to which they are party must contain a representation of the Company and Participant that such employee, consultant or Management Company Employee, as the case may be, is a bona fide employee, consultant or Management Company Employee of the Company or its subsidiaries.
- 7.3 A Participant who has been granted an Option may, if such Participant is otherwise eligible, and if permitted under the policies of the Exchange and terms hereof, be granted an additional Option or Options if the Board shall so determine.

8. EXERCISE PRICE

8.1 Options may be exercised at a price that shall be fixed by the Board at the time that the Option is granted (the "**Exercise Price**"). No Option shall be granted with an Exercise Price at a discount to the market price. The market price shall be the closing price of the Shares on the Exchange on the first day preceding the date of grant on which at least one board lot of Shares traded.

8.2 Once the Exercise Price has been determined by the Board, accepted by the Exchange and the Option has been granted, the exercise price of an Option may be reduced upon receipt of Board approval, provided that in the case of Options held by Insiders (as defined in the policies of the Exchange) of the Company, the Exercise Price of an Option may be reduced only if disinterested shareholder approval is obtained.

9. NUMBER OF OPTIONED SHARES

- 9.1 The aggregate number of Shares issuable upon the exercise of all Options granted under the Plan (as well as all Shares issuable pursuant to any other securities based compensation plans of the Company) shall be fixed at 19,183,048 and shall not exceed 20% of the issued and outstanding Shares of the Company as October 19, 2023 (unless the Company has obtained the requisite disinterested shareholder approval), subject to the following additional limitations:
 - (a) the aggregate number of Shares issuable pursuant to all Security Based Compensation granted to any one Participant (and companies wholly owned by that Participant) in a twelve (12) month period must not exceed 5% of the issued and outstanding Shares, calculated on the date the Security Based Compensation is granted or issued to the Participant (unless the Company has obtained the requisite disinterested shareholder approval);
 - (b) the maximum number of Shares reserved for issuance pursuant to all Security Based Compensation granted to Insiders (as a group) must not exceed 10% of the issued and outstanding Shares at any point in time (unless the Company has obtained the requisite disinterested shareholder approval);
 - (c) the grant to Insiders (as a group), within a twelve (12) month period, of an aggregate number of Security Based Compensation must not exceed 10% of the issued and outstanding Shares, calculated as at the date the Security Based Compensation is granted or issued to any Insider (unless the Company has obtained the requisite disinterested shareholder approval);
 - (d) the aggregate number of Security Based Compensation granted to any one Consultant, within a twelve (12) month period, must not exceed 2% of the issued and outstanding Shares, calculated as at the date the Security Based Compensation is granted or issued to the Consultant; and
 - (e) the aggregate number of Options granted to all persons employed to provide investor relation activities shall not exceed 2% of the issued and outstanding Shares of the Company in any twelve (12) month period, calculated as at the date an Option is granted or issued to any such person. Options granted to persons retained to perform investor relations activities will contain vesting provisions such that vesting occurs over at least 12 months with no more than 1\4 of the options vesting in any 3 month period.
- 9.2 The number of Shares subject to an Option granted to any one Participant shall be determined by the Board, but no one Participant shall be granted an Option which exceeds the maximum number permitted by the Exchange.
- 9.3 Consultants performing investor relations activities may not receive any Security Based Compensation other than stock options.

10. DURATION OF OPTION

- 10.1 Each Option and all rights thereunder shall be expressed to expire on the date set out in the Option agreement and shall be subject to earlier termination as provided in Sections 15 and 16, provided that in no circumstances shall the duration of an Option exceed the maximum term permitted by the Exchange. For greater certainty, if the Company is listed on the TSX Venture Exchange, the maximum term may not exceed 10 years from the date of grant (subject to extension where the expiry date falls within a Black Out Period, as defined herein).
- 10.2 Should the expiry date of an Option fall within a Black Out Period or within nine (9) business days following the expiration of a Black Out Period, such expiry date of the Option shall be automatically extended without any further act or formality to that date which is the tenth (10th) business day after the expiry of the Black Out Period, such tenth (10th) business day to be considered the expiry date for such Option for all purposes under the Plan. The ten (10) business day period referred to in this paragraph may not be extended by the Board.
- 10.3 **"Black Out Period**" means the period during which the relevant Participant is prohibited from exercising an Option due to trading restrictions imposed by the Company pursuant to any internal trading policy of the Company as a result of the bona fide existence of undisclosed material information. The internal trading policy of the Company is in respect of a restriction on trading that is in effect at that time or a notice in writing to a Participant by a senior officer or director of the Company. The Black Out Period shall expire following the general disclosure of the undisclosed material information.

11. HOLD PERIOD

All Options are subject to Exchange hold periods where applicable. A 4-month hold period (commencing on the date the Options are granted) is required for Options granted to Insiders or granted at any discount to the market price.

12. OPTION PERIOD, CONSIDERATION AND PAYMENT

- 12.1 The Option period shall be a period of time fixed by the Board not to exceed the maximum term permitted by the Exchange, provided that the Option period shall be reduced with respect to any Option as provided in Sections 15 and 16 covering cessation as a director, officer, consultant, employee or Management Company Employee of the Company or its subsidiaries, or death of the Participant.
- 12.2 Subject to any vesting restrictions imposed by the Exchange, the Board may, in its sole discretion, determine the time during which Options shall vest and the method of vesting, or that no vesting restriction shall exist. For greater certainty, no Option shall vest before one year from date of issuance or grant.
- 12.3 Acceleration of vesting is permitted in connection with Participant's death or where Participant ceases to be an eligible Participant in connection with a change of control, takeover bid, reverse take-over or other similar transaction. There shall be no acceleration of the vesting provisions to Options issued to persons employed to provide investor relation activities without prior Exchange acceptance.
- 12.4 Subject to any vesting restrictions imposed by the Board, Options may be exercised in whole or in part at any time and from time to time during the Option period. To the extent required by the Exchange, no Options may be exercised under this Plan until this Plan has been approved by a resolution duly passed by the shareholders of the Company.

- 12.5 Except as set forth in Sections 15 and 16, no Option may be exercised unless the Participant is at the time of such exercise, a director, officer, consultant, or employee of the Company or any of its subsidiaries, or a Management Company Employee of the Company or any of its subsidiaries.
- 12.6 The exercise of any Option will be contingent upon receipt by the Company at its head office of a written notice of exercise ("**Option Exercise Notice**"), specifying the number of Shares with respect to which the Option is being exercised, accompanied by cash payment, certified cheque or bank draft for the full purchase price of such Shares with respect to which the Option is exercised (subject to Section 21.1. No Participant or his legal representatives, legatees or distributees will be, or will be deemed to be, a holder of any Shares of the Company unless and until the certificates for Shares issuable pursuant to Options under the Plan are issued to him or them under the terms of the Plan.

13. CASHLESS EXERCISE

- 13.1 Without limiting the foregoing Section 12.6, unless otherwise determined by the Board or not compliant with any applicable laws or rules of any applicable securities exchange or market, a Participant may elect cashless exercise in its Option Exercise Notice. In such case, the Participant will not be required to deliver to the Company a cheque or other form of payment for the aggregate Exercise Price referred to above. Instead the following provisions will apply:
- 13.2 The Participant will instruct a broker selected by the Participant to sell through the stock exchange or market on which the Shares are listed or quoted, sufficient number of Shares issuable on the exercise of Options to cover the Exercise Price, as soon as possible upon the issue of such Shares to the Participant at the then applicable bid price of the Shares.
- 13.3 Before the relevant trade date, the Participant will deliver the Option Exercise Notice including details of the trades to the Company electing the cashless exercise and the Company will direct its registrar and transfer agent to issue a certificate for such Participant's Shares in the name of the broker (or as the broker may otherwise direct) for the number of Shares issued on the exercise of the Options, against payment by the broker to the Company of (i) the Exercise Price for such Shares; and (ii) the amount the Company determines, in its discretion, is required to satisfy the Company withholding tax and source deduction remittance obligations in respect of the exercise of the Options and issuance of Shares.

14. NET EXERCISE

14.1 Subject to prior approval by the Board, a Participant may elect to surrender for cancellation to the Company any vested Options being exercised and the Company will issue to the Participant, as consideration for the surrender of such Options, that number of Shares (rounded down to the nearest whole Share) on a net issuance basis in accordance with the following formula below:

$$X = \frac{Y (A-B)}{A}$$

where:

- X = The number of Shares to be issued to the Participant in consideration for the net exercise of the Options under this Section 14;
- Y = The number of vested Options with respect to the vested portion of the Option to be surrendered for cancellation;

- A = The volume weighted average trading price of the Shares on the Exchange calculated by dividing the total value by the total volume of such securities trade for the five trading days immediately preceding the exercise of the subject Option; and
- B = The Exercise Price for such Options.
- 14.2 Persons employed to provide investor relation activities shall not use the Net Exercise provisions as defined in this Section 14 to exercise Options.

15. CEASING TO BE A DIRECTOR, OFFICER, CONSULTANT OR EMPLOYEE

- 15.1 If a Participant shall cease to be a director, officer, consultant, employee of the Company, or its subsidiaries, or ceases to be a Management Company Employee, for any reason (other than death), such Participant may exercise his Option to the extent that the Participant was entitled to exercise it at the date of such cessation, provided that such exercise must occur within 90 days after the Participant ceases to be a director, officer, consultant, employee or a Management Company Employee, unless such Participant was engaged in investor relations activities, in which case such exercise must occur within 30 days after the cessation of the Participant's services to the Corporation, subject to extension at the discretion of the Board.
- 15.2 Nothing contained in the Plan, nor in any Option granted pursuant to the Plan, shall as such confer upon any Participant any right with respect to continuance as a director, officer, consultant, employee or Management Company Employee of the Company or of any of its subsidiaries or affiliates.

16. DEATH OF PARTICIPANT

Notwithstanding Section 12, in the event of the death of a Participant, the Option previously granted to him shall be exercisable only within the one year after such death and then only:

- 16.1 by the person or persons to whom the Participant's rights under the Option shall pass by the Participant's will or the laws of descent and distribution; and
- 16.2 if and to the extent that such Participant was entitled to exercise the Option at the date of his death.

17. RIGHTS OF OPTIONEE

No person entitled to exercise any Option granted under the Plan shall have any of the rights or privileges of a shareholder of the Company in respect of any Shares issuable upon exercise of such Option until certificates representing such Shares shall have been issued and delivered.

18. PROCEEDS FROM SALE OF SHARES

The proceeds from the sale of Shares issued upon the exercise of options shall be added to the general funds of the Company and shall thereafter be used from time to time for such corporate purposes as the Board may determine.

19. ADJUSTMENTS

19.1 If the outstanding Shares of the Company are increased, decreased, changed into or exchanged for a different number or kind of shares or securities of the Company or another Company or entity through re- organization, merger, re-capitalization, re-classification, stock dividend, subdivision or consolidation, or any adjustment relating to the Shares

optioned or issued on exercise of Options, or the exercise price per share as set forth in the respective Option agreements, shall be adjusted in accordance to the terms of such agreements.

- 19.2 Adjustments under this Section shall be made by the Board whose determination as to what adjustments shall be made, and the extent thereof, shall be final, binding and conclusive. No fractional Share shall be required to be issued under the Plan on any such adjustment.
- 19.3 Any adjustment, other than in connection with a consolidation or split, to Security Based Compensation granted or issued under a Security Based Compensation plan are subject to prior acceptance of the Exchange, including adjustments related to an amalgamation, merger, arrangement, reorganization, spin- off, dividend or recapitalization.

20. TRANSFERABILITY

All benefits, rights and Options accruing to any Participant in accordance with the terms and conditions of the Plan shall not be transferable or assignable unless specifically provided herein or the extent, if any, permitted by the Exchange. During the lifetime of a Participant, any benefits, rights and Options may only be exercised by the Participant.

21. WITHHOLDING TAXES

The Company shall have the authority to take steps for the deduction and withholding, or for the advance payment or reimbursement by the optionee to the Company, of any taxes or other required source deductions which the Company is required by law or regulation of any governmental authority whatsoever to remit in connection with this Plan, or any issuance of Shares. Without limiting the generality of the foregoing, the Company may, in its sole discretion:

- 21.1 deduct and withhold additional amounts from other amounts payable to a optionee;
- 21.2 require, as a condition of the issuance of Shares to an optionee, that the optionee make a cash payment to the Company equal to the amount, in the Company's opinion, required to be withheld and remitted by the Company for the account of the optionee to the appropriate governmental authority and the Company, in its discretion, may withhold the issuance or delivery of Shares until the optionee makes such payment; or
- 21.3 sell, on behalf of the optionee, all or any portion of Shares otherwise deliverable to the optionee until the net proceeds of sale equal or exceed the amount which, in the Company's opinion, would satisfy any and all withholding taxes and other source deductions for the account of the optionee.

22. AMENDMENT AND TERMINATION OF PLAN

- 22.1 The Board may terminate or discontinue the Plan at any time without the consent of the Participants provided that such termination or discontinuance shall not alter or impair any Option previously granted under the Plan.
- 22.2 The Board may not amend this Plan or issuances of Options without prior Exchange acceptance and shareholder approval where applicable. For greater certainty, without limitation, amendments to any of the following provisions of the Plan will be subject to shareholder approval:
 - (a) persons eligible to be granted or issued Options under the Plan;

- (b) the maximum number or percentage, as the case may be, of listed shares that may be issuable under the Plan;
- (c) the limits under the Plan on the amount of Options that may be granted or issued to any one person or any category of persons (such as, for example, Insiders);
- (d) the method for determining the exercise price of the Options;
- (e) the maximum term of the Options;
- (f) the expiry and termination provisions applicable to the Options, including the addition of a blackout period;
- (g) the addition of a Net Exercise provision; and
- (h) any method or formula for calculating prices, values or amounts under the Plan that may result in a benefit to a Participant, including but not limited to the formula for calculating the appreciation of a Stock Appreciation Right (as defined in the policies of the Exchange).
- 22.3 Notwithstanding the foregoing, the following types of amendments to the Plan are not subject to shareholder approval:
 - (a) amendments to fix typographical errors; or
 - (b) amendments to clarify existing provisions of the Plan which does not have the effect of altering the scope, nature and intent of such provisions.
- 22.4 Where shareholder approval is sought for amendments to reduce the exercise price of an outstanding Option, including a cancellation of an Option and re-grant of an Option in conjunction therewith, constituting a reduction of the exercise price of the Option, the votes attached to Shares held directly or indirectly by Insiders benefiting from the amendments will be excluded.
- 22.5 Disinterested shareholder approval must be obtained for any reduction in the exercise price of an Option, or the extension of the term of an Option, if the Participant is an Insider of the Company at the time of the proposed amendment.

23. NECESSARY APPROVALS

The ability of a Participant to exercise Options and the obligation of the Company to issue and deliver Shares in accordance with the Plan is subject to any approvals which may be required from shareholders of the Company and any regulatory authority or stock exchange having jurisdiction over the securities of the Company. If any Shares cannot be issued to any Participant for whatever reason, the obligation of the Company to issue such Shares shall terminate and any Option exercise price paid to the Company will be returned to the Participant.

24. EFFECTIVE DATE OF PLAN

The Plan has been adopted by the Board of the Company subject to the approval of the Exchange and, if so approved, subject to the discretion of the Board, the Plan shall become effective upon such approvals being obtained.

25. INTERPRETATION

Terms used but not otherwise defined herein shall have the meanings ascribed thereto in the Company Manual of the TSX.

26. GOVERNING LAW

This Plan will be governed by and construed in accordance with the laws of Ontario and the laws of Canada applicable therein.
